new website to make it a more powerful tool for education, communication and water protection.

We have funded our operations through memberships and your generous contributions... THANK YOU!! Our annual expenditures are approximately \$250,000 of which our most significant line items are Water Quality, Invasive Species, Education and Member Communications.

It's all about the Groundwater Watershed

Two Watershed Boundaries


Did you know that the Glen Lake/Crystal River Watershed has two boundaries? The first, a state-approved surface water watershed that delineates the area from which rain/snowmelt travels over the surface of the land to join the surface waters of our watershed. The second, a groundwater watershed boundary, covers a larger area and contains both the surface water and groundwater that flows into our lakes and streams. Both are used in a variety of ways including long-term planning for water quality protection such as state approved watershed plans and even specialized regulation and zoning. Glen Lake is a spring-fed lake, with more than 50% of its water coming from groundwater and less than half from direct precipitation or surface water flow. So what we do on land can have a large impact on water quality, both directly and more significantly indirectly.

Watershed Plan Update

The GLA and its partners utilize a state-approved, comprehensive watershed plan as the guide for protecting our watershed, however our last plan was more than 20 years old! Fortunately, in 2019, the GLA received a \$25,000 grant to offset the cost of creating the much needed update. A 12-member steering committee has been working together over the past two years to compile the new plan and the more than 200 page document has now been submitted for formal review by the State of Michigan. Not only will the final updated plan be a tremendous guide for the next decade, it also positions the GLA to be eligible for future state grants. High thanks to those members who served on the steering committee!

Priority and Critical Areas

There are certain areas within the watershed, in addition to groundwater recharge areas, that warrant more extensive management consideration. Priority areas in the watershed are defined as the areas that are most sensitive to environmental impacts and have the greatest likelihood to affect water quality and aquatic habitat.



Our First Line of Defense

For more than 26 years, the GLA Boat Wash Station has been a model for other watersheds, offering boat decontamination services free of charge May through October, 24 hours a day, seven days a week. So far we have been successful in preventing additional aquatic invasive species from entering our waters while other nearby lakes are increasingly plagued by aggressive non-native aquatic species such as Eurasian watermilfoil. Glen Lake has held its own aided by the Boat Wash and local ordinances. Glen Arbor and Empire Townships, home to the MDNR launch site on Little Glen Lake were the first in the state to establish Boat Wash ordinances, those ordinances were the inspiration for Michigan's recently enacted aquatic invasive species laws.

We are extremely proud of our Boat Wash Program. Though only one of our many programs designed to protect water quality, it is our first line of defense. Detailed Boat Wash user data is collected via interview with each public access user including services provided, origination of watercraft and number and types of invasive species detected and removed. One highlight of each season is providing boat inspection and washing services for the Annual M22 Challenge Triathlon event. On top of the 1.7 million summer visitors from the nearby Sleeping Bear Dunes National Lakeshore (which comprises 40% of our watershed area), the M22 Challenge brings in competitors and their friends and family from all over the country and adds another thousand or more boats to our regular season Boat Wash traffic.

Over the course of its operation, the Boat Wash has screened tens of thousands of vessels and shows no sign of slowing down. In the past two years alone, boats passing through the station have increased by 33%, that's nearly 500 more boats a season! The Traverse City Area and the Dunes have been discovered, Glen Lake is no exception. If we are to ensure that the Glen Lake/Crystal River Watershed stays healthy and blue for future generations, our Boat Wash Program will need ongoing support.

Focus on Fish




2021 Creel Survey by the Numbers

Fisheries Sensitive to Changing Weather Patterns

The highly visible fish kill on Little Glen in May of 2021 was a rare event. According to our state fisheries biologist, it appeared that many fish species had moved onto their shallow

water spawning beds when a weather related rapid rise in air temperature and subsequent rapid rise in water temperature proved more than the fish could tolerate.

Hopefully, we will not witness this type of event again, but it speaks to how sensitive our waters are to rapidly changing weather conditions. The increased frequency of extreme temperature swings and high intensity rain events could spell real concern for our fisheries unless we do all we can to mitigate the impacts. Natural and bioengineered shorelines serve not only

to buffer shores from wind, waves and ice, but can also prevent erosion and sedimentation from intense rainfall and reduce effects of rapid changes in air temperature.





Avoid the Itch!

Did you know that the latest research shows only about 30% of people are affected by swimmer's itch?

If you're one of the unlucky ones with the allergy to the parasite that causes swimmer's itch or simply prefer not to find out if you are, you can avoid exposure by taking a few precautions listed in the graphic below. The GLA also continues to partner with the international North American Swimmer's Itch Reporting Network in an effort to better predict and understand swimmer's itch. We encourage anyone who does experience a reaction to use the swimmer's itch reporting link posted on the GLA website. 38 cases were reported in 2021. Be sure to both report and map your "itch", as this data is invaluable to ongoing research efforts to prevent swimmer's itch.






Water Level Committee Highs and Lows for 2021

Did you know the topic of lake level predates and was a key factor in the formation of the GLA more than 76 years ago? Here's an overview for 2021.



The blue dots are occasional readings of the staff gauge attached to the narrows bridge. These readings show that the auto gauge is reading correctly. The up spikes in lake level in May through July demonstrating a series of rain events of 0.15 feet (1.8 inches) and more. Like last year, we did not experience much summer drought or subsequent drop in lake level in late July and August.









The river flow chart for the year shows increased activity in gate changes as our weekly captains reacted to the rainstorms, raising and lowering the gates as necessary. The captains made 34 dam changes during the year. River flow never went below the minimum of 31 cubic feet per second target for more than a day. High flow caused breaching of the riverbank near the old mill in mid-July which was met with volunteer action to raise the dam for a couple of days. A meeting of the WLC was called to discuss the event and the positive response to it, resulting in an addition to the WLC Captain's Responsibility document. It was also noted that no serious culvert blockage occurred during the year.




years yielding an upside-down comparison to the river flow graph. Gates running lower through the years indicates more



In 2021 the WLC calculated the yearly average river flow for the past decade. Using our website, it is easy to bring yearly data into a spread sheet and average it over 365 days. The trend is increasing flow indicating more rain. This is an interesting use of the data we gather

Septic Study

With the absence of any sewer system in our watershed, all our wastewater goes into the ground for filtering, but growing numbers of visitors and residents have steadily increased the load. 2022 marks the third and final year of the GLA sampling well and lake water as part of a multi-lake study that should yield valuable data on the influence of septic systems on our drinking and recreational water. Don't take the chance that your system is malfunctioning. Avoid costly repairs and water contamination by scheduling an inspection of your septic system. Inspection is recommended every 3 years depending on usage and be sure to have your system pumped if indicated.

On the Hunt

Luckily, low nutrient levels present in Glen Lake result in shoals that for the most part lack expansive underwater aquatic vegetation. However, we do have several areas where very diverse, healthy aquatic gardens thrive and the GLA monitors them in several ways for any changes. We are hyper focused on any sign of Eurasian Watermilfoil. If left unchecked, Eurasian Watermilfoil would cause great damage to our ecosystem. We depend on our Boat Wash to keep out invasive species, but also stand ready to act immediately should any be found.

Our Third Round of Shoreline Surveys

GLA will conduct a third shoreline survey this summer and with this information we will be able to statistically evaluate how riparian shoreline practices are impacting water quality. More lakes in the region are engaging

in this type of monitoring, with standardized methodologies of capturing and evaluating the data, the ability to track changes, both positive and negative, is now possible. Crystal River Health Index



The Crystal River is scheduled for a "health checkup" during the summer of 2022. The basis of the checkup is to survey for specific, sensitive aquatic insects that if found, indicate that water quality is good. As with past evaluations, we hope to find that the river continues to be in good health in 2022.


